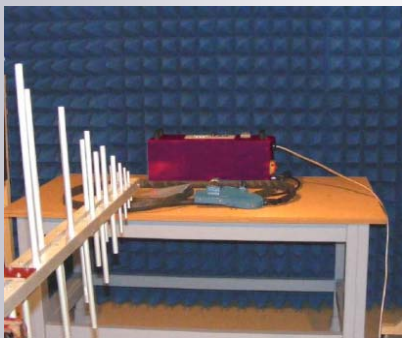

Product Compliance Assistance for SME's

Through the Manufacturing Advisory Service (MAS) and West Midlands Centre for Constructing Excellence (WMCCE), the CE Marking Association is able to give assistance to companies who may have problems meeting CE requirements; this can be 50% or more of assistance and in some cases up to 30 days dependent upon eligibility and location. Applicants must be an SME manufacturing company in the UK, who has not received more than €200,000 of assistance over the last three years.

Examples of project could be:

- Technical (Construction) File compilation
- EMC design advice
- Conducting Risk Assessments
- Defining and interpreting the applicable standards
- Pre-compliance testing and assessments
- International compliance guidance



The decision process is quick and simple. The client requests a project through Wemtech or direct with MAS, and MAS will provide an instant decision. There is no business plan required and no red tape, just one simple document to complete and sign off at the end.
